We investigate all kinds of uh, this type of uh (inaudible) 14 Q (Inaudible) A 15 (Inaudible) cutting people, stuff of that nature. 16 Q (Inaudible) 17 Α Assaults and batteries and all that good stuff. 18 Q 19 Α (Inaudible) Okay John, this is what we got, I'm just gon' lay it out for you, okay. 20 Q 21 (Inaudible) Α 22 Right now, we got Q (Phone beeping) 23 (inaudible) several people saying you guys, you and your girlfriend at the uh, the 24 25 uh, Doll House.

5	Q	Like he was saying (inaudible) fight that took place in the parking lot.

7 7	Q	Okay and we already know all that, okay.
8	А	Uh huh (Affirmative)
9	Q,	And uh, (inaudible) just want your side of the story of what happened.
10	A	(Inaudible)
11	Q	That's the only thing we want, you know.

13	Q	There's a couple of guys we know that got stabbed, okay. So we just want your
14		side of the story of what happened, all right. Cause there's always two sides to
15		every story.
16	Α	Uh huh (Affirmative)
17	Q	You know what I mean. And uh, we just want you to tell us what (inaudible).
18		(Door opened and closed)
19	Q	(Inaudible)
20		(DETECTIVE PHELAN)
21	Q	I know he was explaining, but basically this is what, how it goes. Uh, (inaudible)
22	8	got blood all over you, we know you're involved in (inaudible). We all know how
23		it started; we got one side of it. We got their side of what happened, okay.
24	А	(Inaudible) do you have surveillance cameras for the parking lot?
25		

1	Q	Yes they do. But unfortunately for you, the surveillance cameras only covered
2		the front half of the parking lot. The area where you were, you know, (inaudible).
3		But the area where the fight occurred, you know.

5	Q	So yeah, (inaudible), we have the people working there.

7	Q	Huh?

15	Q	Okay, first before we (inaudible), I have to read you your rights, okay, because
16		this is a crime. And you do have rights, okay.

18	Q	(Inaudible). Our whole intentions, uh, to get your side, so we have both sides. I
19		don't just arrest, I don't arrest a person just to be arresting because somebody
20		said this happened. I look at both sides.
21	Α	(Inaudible) even arrested.
22	Q	Okay. We have the right, well you haven't been until you go (inaudible); you see
23		what I'm saying.
24	Α	(Inaudible)
25	Q	Okay you have the right to remain silent. Do you understand that?

1	A	Yes.
2	Q	(Inaudible) anything you say is used against you in court. Do you understand
3		that?
. 4	A.	Yes.
5	Q	You have the right to talk, talk to a lawyer before and during questioning. Do you
6		understand that?
7	Α	Yeah.
8	Q	Okay. Okay. Now as I was saying, my whole intentions is to get your, to get
9		your girlfriends side, to get your side. I got their side of what happened. I don't
10		know what started this, they, they were pretty vague on what started this.

12	Q	Okay, so uh, why we're here is to get the whole story.
13	Α	Uh huh (Affirmative)
14	Q	Okay and with that in mind do you want to tell us what happened?
15	А	(Inaudible)
16	Q	Yall were inside the, yall met inside the club?
17	Α	(Inaudible)
18	Q	(Inaudible)
19	Α	(Inaudible)
20		(DETECTIVE TALTON)
21	Q	What about his hair, did he have long hair, short hair?
22	Α	It looked like some kind of braided, dread thing.
23	Q	Like braids coming to the side (inaudible).
24	A	No they were more going up (inaudible). It was like (inaudible) out the door.
25	Q	Okay.

19	98.	got the security around him and he grabbed his girl and he left". You know, and
20		he called me a player before so I figured it was just gonna be a conversation, you
21		know. So, I mean, basically he said that and I was like kinda thrown off like. You
22		know and they was kinda laughing so I was like you know, (inaudible). So
23		(inaudible) to get in the car. I went to the back of my car but one of the guys
24		started walking towards me fast then I caught the vibe. Hold up, this guy looks

14	Α	Yeah, you know, (inaudible) was gon' come over there.
15	_Q	So were actually in, like in conversation or?
16	Α	Well you know, I heard what he said and I was getting ready to say, "Hey yo
17		man", you know what I'm saying, "There's plenty of girls available, I (inaudible).
18		You know, but then I seen his boy rushing towards me like, you know, like I said,
19		boom. So then (inaudible) started swinging and man I'm telling them, boy yo,
20		ain't gon' be no fighting or none of that shit, right, you know, my girl already
21		sitting in the car cause I unlocked the door for her. And um, all of a sudden he hi
22		me, boom. Let he came up to me and he just hit me, boom, and I'm like, where
23		the hell is this coming from. You know, so I tried to back him up a little bit and I

25	Q	When this guy hit you did he hit you in the face?

1	А	Yeah he hit in the face kinda but I kinda like moved a little bit. And he still hit me
2		in the face though, you know, he still hit me in the face. Anyway, boom, you
3		know but I was dizzy after that.
4		(DETECTIVE PHELAN)
5	Q	Did you have anything to drink?
6	Α	Me I had, I had a drink.
7	Q	How many different drinks?
8	А	Like 1 or 2. (Inaudible) matter of fact I had one
9	Q	What, what was it?
10	Α	Heineken.
11	Q	Heineken beer?
12	Α	Uh huh (Affirmative)
13	Q	Had you had anything to smoke anything, any drugs that would alter your?
14	Α	(Inaudible) no drugs.
15	Q	So your recollection is clear of what happened?
16	Α	Up until the point where the, I mean, the, the kid was banging me around like
17	246	a rag doll and (inaudible)
18	Q	(Inaudible)
19	A	Huh?
20	Q	This is the one that's stout, the first one?
21	Α	Yeah, but all of them was bigger than me.
22	Q	Okay.
23	Α	I mean, you know.
24	Q	So he hit you.
25	A	He hit me (inaudible)

1.	Q	You got in his face?
2	Α	Well, you know, was it was was like he hit me and it was automatically a fight.
3		And you know (inaudible) then I was thinking like you know, I'm gonna have to hit
4		this guy in his head.
5	Q	Uh huh (Affirmative)
6	Α	So I tried to hit him and then, you know, I seen the other guys coming, you know,
7		and that's when I, I had a pocket knife, so I pulled it out you know what I'm
8		saying.
9	Q	Where was it at?
10	А	Where was the pocket knife?
11	Q	In your front pocket?
12	Α	It was in my back pocket. I had originally told them that it wasn't mine but it was.
13		Then after that I couldn't remember nothing because the guy is on my shirt and
14		one of the big guys they was on my shirt. Cause one guy came up, I remember
15		that, and I was like, I looked at him, he didn't move.
16	Q	Uh huh (Affirmative)
17	Α	So I said this guy is gonna faint and I said it out loud.
18	Q	Uh huh (Affirmative)
19	A	So then I just, you know, boom, turned left and I remember, matter of fact, then
20		my girl got out the car because they jumping on me.
21	Q	Uh huh (Affirmative)
22	А	And she tried to push them, get off of him, get off of him, you know. And
23	Q	Did you see any of the workers or the bouncers or anything (inaudible)?
24		

1	Α	I couldn't see nobody, actually I couldn't see nobody I was blacked out. I mean
2		during the whole process I was trying to grab, I was getting hit so many times I
3		was trying to grab, focus, but I was still swinging with the knife.
4	Q	Okay.
5	A	And that was it, that's all I can remember. That's, that's all I can remember
6		except for
7		(DETECTIVE TALTON)
8	Q .	Let me ask you this, how'd you (inaudible) those guys hit you (inaudible)
. · 9	Α	(Pause) I don't know, it was different people hitting me at different times because
10		it was one guy (inaudible), he really had me by my shirt, he musta hit me.
11		(Inaudible), I can't remember, I can't remember. But I know it was
12	Q	Was he the first one that came (inaudible) at you?
13	Α	Huh?
14	Q	The one that had you by your shirt, was he the first one that came at you or one
15		of the others?
16	Α	I think he was the other guy. Yeah he was another guy cause he was the one, I
17		think he was the one who I said is not fighting and I turned around, turned my
18		back on him.
19	Q	Uh huh (Affirmative)
20	Α	And then he was like, (Inaudible).
21	Q	Do you know why we was (inaudible)
22	A	He had (inaudible) too. But actually I don't remember much, you know, all I
23) ₈₀	remember is that I couldn't see, I couldn't even see nothing and they laid off me
24		for a second.
25	0	Uh huh (Affirmative)

1	A	And it was a point that
2	Q	(Inaudible)
3	A	I was grabbing at some of they stuff, trying to grab it, you know, like you know
4		cause I know they had the knife. They had a knife trying to cut me; you know
5		what I'm saying.
6	Q	You know which one had the knife?
7	Α	I don't know.
8	Q	Did they ever cut you?
9	Α	Yeah they cut my arm.
10	Q	The left arm?
11	Α	Yeah the left arm, they cut it. (Inaudible). Matter of fact that's actually, you know,
12		going on at the same time that I pull out mine because you know, I always
13		consider myself with a (inaudible) But I don't remember a lot of stuff because it
14		was like, I was surprised that I didn't get knocked out.
15	Q	Uh huh (Affirmative)
16	А	Like every second I was like, "Oh shit, I got knocked out", you know what I'm
17		saying, that's what I was thinking.
18	Q	Have you ever been in a fight before?
19	Α	I've been in plenty of fights.
20	Q ·	Right, so you knew, you know that surprise is like a guy in his first fight, you know
21		that you can take a lick pretty good.
22	Α	Yeah I know I can take, (inaudible) years old but I don't still fight.
23	Q	So you've been fights before, you know, real fist knuckle down fights.
24	Α	Yeah when I was a kid coming up.

1	Q	(Inaudible) like me, you know, I've been like, (inaudible) like I say, I've been in a
2		few fights (inaudible).
3	A	(Inaudible) so even in the (inaudible)
4	Q	What I'm saying is you know, you were fighting the whole time, you were trying to
5	d	keep them off of you the whole time?
6	Α	Basically.
7	Q	I'm saying
8	Α	(Inaudible) left me alone when they seen me with the knife.
9	Q	Right, they didn't get you down.
10	A	No they didn't get me down.
11	Q	Okay.
12	Α	I don't think so, yes I did, yes they did cause that's why my knee hurts. They did
13		let me down. See my pants like that, they got me down that's why the knee,
14		that's where(Pause) Yeah they did knock me down, they knocked me down
15		and my knee is swollen. I can't remember a lot of stuff because it, because the
16		way it was, you know, I was taking a beating, you know; you know what I'm
17		saying. And the only thing I could do was like get away from me, get away from
18		me.
19	Q	Uh, (inaudible) when did you get the knife? When did you put the knife from your
20		pocket?
21	Α	When did I put it back?
22	Q	When did you put it in your pocket? When, did you go in the club, did you have it
23		when you went in the club?
24	Α	The knife?
25	Q	Yeah.

1	Α	Yeah, it's a um, it's a knife I use to use (inaudible) construction.
2	Q	Uh huh (Affirmative)
3	Α	And I use to hang my jack hammer up when I worked construction for years, so,
.4		you know, but I use to (inaudible) sometimes you got to cut the ropes
5	Q	But I'm saying you had it when you went in the club?
6	Α	Yeah I had that, I had that, I kept it on me.
7	Q	They didn't search you when you went in the club?
8	Α	Nall.
9		(DETECTIVE TALTON)
10	Q	Is that something you always do is keep your knife on you, be honest, (inaudible)
11		you know, you might have some trouble or something like that?
12	Α	Basically.
13	Q	Okay.
14	A	ins માલુકા પ્રિમાર You know because (inaudible) you know, I got, you know, the police told me it
15		was all right as long as it wasn't (inaudible).
16	Q	Was that the blade that locks when you open it does it locks on it own?
17	Α	Yeah it locks.
18	Q	Okay.
19		(DETECTIVE TALTON)
20	Q	Uh, but after it was over with, you got in the car.
21	Α	After it, after it was over with, actually I didn't even look, all I remember is trying
22		to stay focused.
23	Q	Uh huh (Affirmative)
24	А	That's the main thing that I remember, just trying to stay focused, so, cause you
25		know, it, when the, when the police took me out the car.

1	Q	Uh huh (Affirmative)
2	А	You know, and I was standing up, I just went blank, you know I was about to
, 3		pass out. I knew that I would pass out; I passed out before, so I knew if I stayed
4		up, I'm a pass out. So I laid on the car.
5	Q	Uh huh (Affirmative)
6	А	I told them, I'm getting ready to pass out, can we sit down. But now that, you
7		know, I got my wind and stuff, I'm all right, so boom, okay, then, anyway.
8	Q	Do you recall firing a gun?
9	Α	(Inaudible) I didn't fire a gun. I didn't fire the gun, it's not my gun. This is the
10		point, the point is I didn't realize I had the gun until I was already in the car and it
11		was on my lap and I was like I musta grabbed this from one of them. And I was
12		(inaudible) you know, like I grabbed it off of somebody's waist or I grabbed it off
13		the ground.
14		(DETECTIVE TALTON)
15	Q	Okay, so now, you're say that the gun that you had is not your gun.
16	Α	It is not my gun.
17	Q	Do you know who that gun got into your car?
18	A	(Inaudible) I might have brought it to the car, but I'm just saying, I don't know how
19		I got it in my hands.
20	Q	So you're saying that gun then belongs to someone else
21	Α	Yeah,
22	Q	That you were fighting with, is that what you're saying?
23	А	Yeah that's what I'm saying, I'm thinking they probably (inaudible). What I did
24		was scared them up and that's probably why they stopped fighting. (Inaudible), I
25		don't know why they stopped fighting me.

1	Q	Uh huh (Affirmative)
2	Α	You know what I'm saying, so basically I figured it was that cause then, matter of
3		fact, I think it was when I hit the floor but after that, what, what I did was go to the
4		car and I had it in my lap.
5	Q	Uh huh (Affirmative)
6	Α	And I didn't know what to do with it. So I was just like, let me see if it's loaded
7		and so I unloaded it, like you know, unloaded it, like you know, just (inaudible)
8	Q	Is this when you were sitting still in the parking lot or had you already started to
9		leave and you were trying to fool with the gun?
10	Α	(Inaudible)
11	Q	When you got like the pistol when you told me that you had the pistol.
12	Α	Uh huh (Affirmative)
13	Q	Were you checking the pistol while you were still in the parking lot?
14		(DETECTIVE PHELAN)
15	Q	Are while you were driving down the road?
16	Α .	I don't know. I don't know if I was still sitting when I was doing that. I know
17		basically I made sure that it was nothing in it, in the chamber.
18	Q	Uh huh (Affirmative)
19	А	And I took the clip out but then I had it sitting on my lap and I was doing like, you
20		know, wipe, wiping my handprints off of it.
21	Q	Okay.
22	Α	And then I was (inaudible) then I thought about giving it to my girl, I was like nall;
23		I don't want her to touch it. So then what I did was reach over to the back and try
24		to put it some, I was gon' put it somewhere I said let me try to squeeze it in
25		

1		between the seat in the back. (Inaudible) when I was, when I got even further
2		down the road, the police stopped me.
3		(DETECTIVE TALTON)
4	Q	So they stopped you at that point.
5.		(DETECTIVE PEHLAN)
6	Q	Do you recall
7	Α	They stopped me like, you know, they stopped me a while, I, I drove with it on m
8		lap for a while.
9	Q	Uh huh (Affirmative)
10	Α	And then I didn't know if I was gon' throw it out the window or the car, matter of
11		fact it was a car that came up to me and the car, you know, mater of fact, and I
12	-	had it sitting on my lap and I was taking the clip out and the seen me taking the
13		clip out and the just (shrieking sound make) like tried to make a U turn. It was a
14		truck, it was a burgundy truck.
15	Q	Uh huh (Affirmative)
16	А	Matter of fact.
17	Q	(Inaudible) following you.
18	Α	He was following me (inaudible)
19	Q	And he say you shoot at him.
20	Α	I didn't shoot at nobody (inaudible), I didn't shoot at nobody, nobody shot at me.
21		And
22	Q	So uh, you ain't gon' have no gun shot residue on your hand from shooting the
23		gun?
24	Α	No.

1	Q	Okay, so you don't milid if we take a test that check and see if you fired a guit
2		tonight.
3	Α	Of course not.
4		(DETECTIVE TALTON)
. 5	Q	Hey uh John, let me ask you, at the point where you go pulled your knife out,
6		okay, you thought the guys (inaudible).
7	Α	Uh huh (Affirmative)
8	Q	Beat you half to death, okay; at that point do you recall when you pulled your
9		knife out? You know, at the point you pulled your knife out, do you know if you
10		stabbed someone then or you tired to cut someone then, can, can you kind of
11		explain that to me? ì หน่อง
12	Α	Um, first I wanted to make sure that he seen it so he would have backed up, I
13		know that much.
14		(Inaudible, more than one person speaking)
15	Q	Is that how you did? Just, you just popped the knife open like this.
16	Α	Yeah and then I tried to like, you know, I went up to hit him but I, he was hitting
17		me on this side as a matter of fact. I remember the beginning, he was hitting me
18		on this side so I was blocking with my left and I wanted to hit him with my right.
19	Q	Okay.
20	Α	And it came to the point where I couldn't hit him no, I had the knife in my hand
21		but I was trying to hit him with my hand actually.
22	Q	Okay.
23	Α	You know what I'm saying, at the same time I wanted him to back up but he just,
24		he just wouldn't back up. So I guess I might have said, fuck it, like tried to
25		scream at him like cut him, you know what I'm saving, so

- 1	Q	So at that point when you went to swing at him you actually hit him but the knife
2		cut him, is that what you're saying?
3	A	Well actually I was trying but, like you know, (inaudible)
4	Q	Yeah.
5	Α	Like I know I wasn't gon' get a good hit cause my, the way my hand was
6		positioned.
7	Q	Uh huh (Affirmative)
8	Α	It was just (inaudible) I, I didn't think the whole thing was gon' be that serious. It
9		just jumped off crazy.
10	Q	So after you, so, so the first one that was there, he was trying to punch you from
11		the left and you, and you had your knife here in your right, so when you came
12		around and you swung at him like that, right?
13	Α	Yeah, I think I swung at him like that
14	Q	(Inaudible)
15	A	Then I said, after I kept getting hit I just was swinging.
16	Q	Okay, so you just started swinging the knife back and forth?
17	А	Basically.
18	Q	Now did you ever like when you had the knife, I understand cause I been in a
19		couple of fights before when if there's more than a couple of guys that jumping
20		on you, I would be trying my best to try and get, get these guys off of me. So you
21	-	don't recall when you made like a slashing motion and then you stabbed
22		someone?
23	Α	(Inaudible) Nuh
24	Q	Okay, you know, let me explain to you cause this guy had been stabbed in the
25		chest, had a puncture wound in the chest like where you were stabbing like that,

1	he's nut dead બ ઉપયુક્તિ છું છે.) instead of a cut, okay. I mean (inaudible) but what I'm saying is is he stabbed.
2	To tell you the truth, all 3 of them was stabbed in the chest, okay. And what
3	those guys are saying is that you stabbed them, okay.
4	(Inaudible, more than one person speaking)
5	A I'm standing by my car, he comes all the way over there, I, I'm getting hit, I don't
6	know what I
7	(Inaudible, more than one person speaking)
8	A I never stabbed nobody before, you understand, I just keep swinging the knife,
9	you understand.
10	Q Okay, let me ask you this, how many
11	A I didn't even know if I hit (inaudible). I thought, I thought maybe I was missing.
12	Q Yeah, I understand. John but you know if you had to say, how many times do
13	you think you stabbed those guys?
14	A Oh my God, (inaudible). I don't know what the hell was going on man.
15	Q Okay.
16	A I don't know, I would was barely able to stand.
17	Q Okay.
18	A The only reason I was really trying to stand cause the guy was holding my shirt.
19	Q Okay, I've been in some fights before, okay, and I know (inaudible). Dubbs (spraks aver)
20	Listen, I don't want to talk about it no ment. I A (Inaudible) I told you everything man. (Inaudible) Quirt. I'm not going want to talk about to put my wife that position, as more than at the trail everything?) it given over
21	Q iveil, What's it-to you, I mean, you couldn't, you couldn't explain it to us if you want to Tulbus cushings
22	or I mean, but I'm here to try to help you, that's all I'm trying to do. But, but these
23	guys are
24	A (Inaudible) the whole thing was self defense. You know it was somebody else, if

somebody else could be saying self defense or whatever, (inaudible)

1	Q.	John, John, okay, okay, okay let me ask you this last thing, now when you went
2		to your car did you go and sit inside of your car or were you standing out on the
- 3		side of your car the entire time?
#	Α	(Inaudible)
5	Q	Yeah.
6	А	(Inaudible)
1	Q	Yeah, when you first came outta the club.
8	Α	Uh huh (Affirmative)
9	Q	Did you go to your car?
10	Α	I think I was getting ready to sit down.
11	Q	Okay.
12	A	And then, you know, they was talking, I didn't understand exactly what they said,
13		so I got out and I stood up, like you know, I think I went half way down. I think I
14		just unlocked the door for my girl and went half way down. And then I was trying
15	s	to understand what they said to her, you know, and you know, and then I was like
16		(inaudible). But I think he had went half way down and then I, you know, stood
17		up and you know, entertained the conversation, whatever, went to the back. I
18	-	said (inaudible).
19	Q	So you went to sit down in your car and then these guys start talking some shit to
20	-	you
21	A	Well they came, they came up to me.
22	Q	Okay.
23	А	You understand. They came up to me; I didn't come up to them.
24	Q	Uh huh (Affirmative), okay.

1	A	They came up to me, I say it's not gon be no lighting, (maudible) light of
2		whatever. And you know, the guy (inaudible), and then he swung on me.
3		(DETECTIVE PHELAN)
4	Q ·	Did, out of all those 4 guys, had you ever seen any of them before tonight?
5	Α	I never seen, I've only been here, I only came down here to see my kids. I only
6		been here for 2 days.
